

Sir,

This has reference to your letter No. dated 25.12.2013 along with copies of EIA/EMP report seeking environment clearance under the provisions of the EIA Notification, 2006. The ToRs for the project were awarded by the Ministry vide letter of even No. dated 29th May, 2013 for preparation of EIA/EMP report.

2.0 M/s Allied Recycling Ltd. is a Steel manufacturing Unit, which has been manufacturing 80, 000 MTA Steel Ingot/ billets and 73, 000 MTA Steel Wire Rods. The Industry has now proposed to enhance the capacity of the unit by addition of Two no's of Induction furnaces of capacities 6 TPH each. The capacity of the unit after expansion will be 1,50,000 MTA Steel Ingots/ billets & 1, 40, 000 MTA Steel Wire Rods. The total area of the plot is about 20, 866 m². There are no wild life sanctuaries, reserved /protected forests or defence installations, rivers and hill ranges within 10 km of the project. It is about 18 kms from Ludhiana and about 75 kms from Chandigarh. Total cost of the Project is 31.5 crores and 48 lakhs have been provided for pollution control Measures. About 9.5 lakhs will be spent on annual maintenance of such measures.

3.0 The raw materials used are MS/CI Scrap, Sponge/Pig Iron, Ferro alloys Manganese, Ferro Silicon, Aluminium. These will be sourced from Domestic as well as

International Markets. The raw materials used in the manufacturing of structural sections is Steel Ingots and Billets will be sourced from own unit.

4.0 The water requirement for domestic purpose will be 9.6 KLD and evaporation loss will be 15 KLD. There is no use of water in the process. So the total water requirement will be 27 KLD. The total power demand for the unit is about 11.4 MW. This demand will be met by sourcing power from Punjab State Power Corporation Limited from the nearby Sub-station. There will be about 300 persons working in the unit. For Air Pollution Control, Cyclones & Bag filters have been provided on Induction furnace and Scrubber on rolling mills. There will be generation of emission containing SPM. All the processes are closed circuit; as such emission to the atmosphere will be minimal. However, APCD, cyclone, bag filters will be provided at the exit point to arrest particulate matters.

5.0 Public Hearing of the project was conducted by PPCB at site on 27.10.2014 under the Chairmanship of Smt. Amrit Kaur Gill, PCS, Additional Deputy Commissioner (G), Ludhiana. Major issues raised during the public hearing inter alia include repair of roads, employment etc.

6.0 The proposal was considered during the 33^{rd} meeting of the Expert Appraisal Committee (Industry) held on $10^{th} - 11^{th}$ February, 2015. After detailed deliberations, the EAC (I) recommended the project for Environmental Clearance and stipulated Specific Conditions along with other environmental conditions while considering for accord of Environmental Clearance.

- x. Disaster management plan shall be prepared and implemented. Regular drills thereof shall be conducted.
- xi. All the commitments made to the public during public hearing/public consultation shall be satisfactorily implemented and adequate budget provision shall be made accordingly.
- xii. Company shall develop an HSE Policy. All the permanent workers shall be covered under ESI Scheme. The company shall have the provision for treatment of its workers at the local Nursing Homes & Hospitals in case of emergency. Annual Medical Check-up on some medical parameters like Blood test, Chest X-Ray, Eye test, Audiometry, Spirometry etc. shall be conducted amongst the employees of the Company and records maintained thereof.

xiii. At least 2.5 % of the total cost of the project shall be earmarked towards the Enterprise Social Commitment (ESC) based on local needs. The proponent shall prepare a detailed CSR Plan for every next 5 years for the existing-cum-expansion project, which includes village-wise, sector-wise (Health, Education, Sanitation, Health, Skill Development and infrastructure requirements such as strengthening of village roads, avenue plantation, etc) activities in consultation with the local communities and administration. The CSR Plan will include the amount of 2% retain annual profits as provided for in Clause 135 of the Companies Act, 2013 which provides for 2% of the average net profits of previous 3 years towards CSR activities for life of the project. A separate budget head shall be created and the annual capital and revenue expenditure on various activities of the Plan shall be submitted as part of the Compliance Report to RO, Bangalore. The details of the CSR Plan shall also be uploaded on the company website and shall also be provided in the Annual Report of the company.

B. GENERAL CONDITIONS:

- i. The project authorities must strictly adhere to the stipulations made by the Punjab Pollution Control Board and the State Government.
- ii. No further expansion or modifications in the plant shall be carried out without prior approval of the Ministry of Environment, Forests and Climate Change (MoEFCC).
- iii. At least four ambient air quality monitoring stations should be established in the downward direction as well as where maximum ground level concentration of PM₁₀, PM_{2.5}, SO₂ and NO_x are anticipated in consultation with the SPCB. Data on ambient air quality and stack emission shall be regularly submitted to this Ministry including its Regional Office at Chandigarh and the SPCB/CPCB once in six months.
- Industrial wastewater shall be properly collected, treated so as to conform to the standards prescribed under GSR 422 (E) dated 19th May, 1993 and 31st December, 1993 or as amended form time to time. The treated wastewater shall be utilized for plantation purpose.
- v. The overall noise levels in and around the plant area shall be kept well within the standards (85 dBA) by providing noise control measures including acoustic hoods, silencers, enclosures etc. on all sources of noise generation. The ambient noise levels should conform to the standards prescribed under EPA Rules, 1989 viz. 75 dBA (daytime) and 70 dBA (nighttime).
- vi. Occupational health surveillance of the workers shall be done on a regular basis and records maintained as per the Factories Act.

An implementation schedule for implementing all the conditions stipulated herein shall be submitted to the Regional Office of the Ministry at Chandigarh. The funds so provided shall not be diverted for any other purpose.
- x. A copy of clearance letter shall be sent by the proponent to concerned Panchayat, Zila Parishad/Municipal Corporation, Urban Local Body and the local NGO, if any, from whom suggestions/representations, if any, were received while processing the proposal. The clearance letter shall also be put on the web site of the company by the proponent.
- xi. The project proponent shall upload the status of compliance of the stipulated environment clearance conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of the MOEFCC at Chandigarh. The respective Zonal Office of CPCB and the SPCB. The criteria pollutant levels namely; PM₁₀, SO₂, NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the projects shall be monitored and displayed at a convenient location near the main gate of the company in the public domain.
- xii. The project proponent shall also submit six monthly reports on the status of the compliance of the stipulated environmental conditions including results of monitored data (both in hard copies as well as by e-mail) to the Regional Office of MOEFCC, the respective Zonal Office of CPCB and the SPCB. The Regional Office of this Ministry at Chandigarh / CPCB / SPCB shall monitor the stipulated conditions.
- xiii. The environmental statement for each financial year ending 31st March in Form-V as is mandated to be submitted by the project proponent to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be put on the website of the company along with the status of compliance of environmental conditions and shall also be sent to the respective Regional Office of the MOEFCC at Chandigarh by e-mail.

- xiv. The Project Proponent shall inform the public that the project has been accorded environmental clearance by the Ministry and copies of the clearance letter are available with the SPCB and may also be seen at Website of the Ministry of Environment, Forests and Climate Change (MoEFCC) at http://envfor.nic.in. This shall be advertised within seven days from the date of issue of the clearance letter, at least in two local newspapers that are widely circulated in the region of which one shall be in the vernacular language of the locality concerned and a copy of the same should be forwarded to the Regional office at Chandigarh.
- xv. Project authorities shall inform the Regional Office as well as the Ministry, the date of financial closure and final approval of the project by the concerned authorities and the date of commencing the land development work.

8.0 The Ministry may revoke or suspend the clearance, if implementation of any of the above conditions is not satisfactory.

9.0 The Ministry reserves the right to stipulate additional conditions if found necessary. The Company in a time bound manner shall implement these conditions.

10.0 The above conditions shall be enforced, inter-alia under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, Hazardous Wastes (Management, Handling and Tran boundary Movement) Rules, 2008 and the Public (Insurance) Liability Act, 1991 along with their amendments and rules.



- 3. The person authorised shall not rent, lend, sell, transfer or otherwise transport the hazardous and other wastes except what is permitted through this authorisation.
- 4. Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person authorised shall constitute a breach of his authorisation.
- 5. The person authorised shall implement Emergency Response Procedure (ERP) for which this authorisation is being granted considering all site specific possible scenarios such as spillages, leakages, fire etc. and their possible impacts and also carry out mock drill in this regard at regular interval of time;
- 6. The person authorised shall comply with the provisions outlined in the Central Pollution Control Board guidelines on ï_λ¹/₂Implementing Liabilities for Environmental Damages due to Handling and Disposal of Hazardous Waste and Penaltyï_λ¹/₂.
- 7. It is the duty of the authorised person to take prior permission of the State Pollution Control Board to close down the facility.
- 8. The imported hazardous and other wastes shall be fully insured for transit as well as for any accidental occurrence and its clean-up operation.
- 9. The record of consumption and fate of the imported hazardous and other wastes shall be maintained.
- 10. The hazardous and other waste which gets generated during recycling or reuse or recovery or pre-processing or utilisation of imported hazardous or other wastes shall be treated and disposed of as per specific conditions of authorisation.
- 11. The importer or exporter shall bear the cost of import or export and mitigation of damages if any.
- 12. An application for the renewal of an authorisation shall be made as laid down under these Rules.

"Production Unit" means the unit of the generator, where the Hazardous Waste is being generated.

"Party" means either of the parties of this agreement.

"CPCB" means Central Pollution Control Board

2. SCOPE OF SERVICES:

- I. The Operator having authorization and facility, for Collection, Storage, Transportation, Reception, Recycling, Treatment and Disposal of the Hazardous waste.
- **II.** The main mode of disposal shall be recycling / reprocessing the Hazardous Waste and extracting zinc from it i.e. APCD Dust.

3. QUALITY PARAMETERS OF APCD DUST

- I. Zn more than 10% (for details, please refer of Clause 6 of the agreement)
- II. Moisture less than 1 %
- III. Dust not older than 15 days
- IV. Dust should be filled directly into the HDPE bags.
- V. Bags should be properly sealed.
- VI. Dust should be stored in a cool, dry and covered room.

4. OBLIGATIONS OF THE GENERATOR:

I. Process Detail:

The generator, in accordance with the rules, shall provide the entire process details, which lead to generation of Hazardous Waste i.e. APCD Dust, to the operator for the purpose of determining the waste characteristics and to decide parameters for Comprehensive Analysis, as well as its final path way of treatment, storage and disposal before signing the Agreement. In case of any change in process, the generator shall intimate the Operator before sending the Hazardous Waste i.e. APCD Dust from the changed process to the facility.

II. Waste Quantities:

The Generator shall declare the Hazardous Waste quantities at the time of signing the agreement, in the Format as **Annexure-I** to this agreement and thereafter on annual basis, at least 15 days before the start of the next year. III. Categorization of waste:

The responsibility for categorization of hazardous waste i.e. APCD Dust shall be with the Generator, however the Operator shall extend all the possible help and guidance to the Generator for categorization of wastes its detailed characterization.

In event of any dispute between the Operator and Generator on characterization of waste, process of generation, Stabilization etc. Mutually an independent expert will be appoint who shall carry out the necessary tests and provide the necessary clarifications. The fees and the cost of the Independent Expert shall be borne by the Generator. The result of such tests and clarifications by the independent Expert shall be final and binding on the Operator and Generators.

IV. Safety Information:

The safety of the community (human, flora and fauna) during transportation is of prime importance and thus, safety information will be provided by the Generator in **form-8** as amended from time to time, as attached to the Rules.

Further, the Generator shall give to the Operator such information as may be specified by PPCB or as may be required by any statutory body.

V. Packaging and Labeling:

The Generator shall ensure that the Hazardous waste is packaged in a manner suitable for storage and transport and the labeling and packaging shall be easily visible and be able to withstand physical conditions and climate factors. Such packaging and labeling should be in full compliance of the Rules.

VI. Manifest:

The Generator shall provide the Manifest to the Transporter as per the Rules. Upon receipt of a manifested waste, the Operator shall determine if the manifest accurately described the waste it accompanies. Any discrepancy in weight (for shipment over 3%), piece count (for batch or containerized waste shipments, one container per truck load), or waste type are considered significant and should be noted on all copies of the Manifest at the time of signatures. The operator shall try to reconcile the discrepancy with the transporter and Operators promptly. Any discrepancy not resolved within 15 days of waste receipts shall be reported by Operator to PPCB with an explanatory letter and a copy of manifest.

The comprehensive based analysis report shall be used to determine the disposal pathway based on the waste characteristics and as per the Rules and guidelines issued by the Ministry of the Environment and forest, Central Pollution Control Board, Punjab Pollution Control Board and other statutory regulation in respect thereto. Disposal pathway shall be mutually agree with Generator and Operator and shall form the basis for tariff.

The Generator shall provide fresh comprehensive waste analysis reports in One or more of the followings occasion:

- a) There is a change in waste characteristics.;
- b) There is a change in manufacturing process;
- c) There is change in product mix/raw material mix;
- An otherwise known reason for change in waste quantities and characteristics;
- e) A period of two years has lapsed since the submission of the previous comprehensive waste analysis.

IX. Declaration:

The Generator shall give a specific declaration whether or not the Hazardous Waste contains Explosive/Ignitable/Corrosive/Toxic/Odor and other such compounds, which could be detrimental to the environment safety of the facility and to the persons handling it in any manner.
